# 1.1. Brief outline of the programme

# 1.2. Brief description of the programme

The Master's degree programme Art and Public Space is a two-year artistic research programme that focuses on how art and artistic practice are made manifest in, function in, and relate to various public environments outside art institutions' traditional venues of display.

According to an institutional theory of art, 'art in public space' is understood as art that avails itself to members of the public who are outside the traditional spaces of art institutions (museums, galleries, 'the white cube', etc.).

Since the program is not medium-specific, it can be linked equally well to new expressions or practices in non-traditional fields of art as to traditional artistic expressions.

The core of the programme concerns developing and creating art in public spaces, also analysing and exploring the artwork's encounter with different types of public spaces, conditions for reception and social structures. The programme gives practical and theoretical insight into public space as a complex, many-faceted arena. The course work should stimulate innovative thinking and increase the development of art and public space on a national and international level.

The programme has special teaching arrangements for English-speaking students so that all courses and options can be completed without being proficient in Norwegian.

## 1.3. Admission

To enrol in the Master's degree programme, the applicant must have completed a three-year Bachelor's degree in visual arts, or have completed an equivalent degree which included subjects and coursework with at least 80 study credits that are relevant to the programme Master of Art and Public Space.

The applicant's qualifications, artistic level and aptitude as related to the Master's degree program will also be evaluated on the basis of documented artworks, involvement and qualifications in the chosen field (artistic level), plus a submitted text explaining the applicant's aims and motivation for seeking to enrol in the programme. Special emphasis will be placed on whether the applicant demonstrates an investigative attitude and ability to engage in a range of problem areas, an ability to take initiative, and a capacity for work.

Applicants must demonstrate proficiency in English.

Applicants may be required to attend an interview.

# 1.4. Learning outcomes

The study programme will provide students with knowledge on how to create art project and other forms of cultural communication for a complex public realm.

Completion of the study programme qualifies graduates for admittance to the Norwegian Artistic Research Programme and other relevant PhD programmes. It also qualifies graduates to develop and create different public art projects, both on their own initiative and as part of a commission, and to work as artistic consultants and mediators.

The study programme is designed to enhance students' awareness, reflection and knowledge around public art, and to provide them with the necessary skills to create, initiate, plan and run different types of art projects in a range of public spaces, beyond the traditional art gallery. The study programme will enhance artists' artistic, practical and theoretical knowledge of art production for different public spaces.

# 1.5. Structure and implementation

The Master of Art and Public Space is divided into 11 courses:

The scope of each course is indicated by the number of credits it awards. 60 credits in the European Credit Transfer and Accumulation System (ECTS) are equal to one year of full-time study. One credit represents 25-30 working hours for a student. In practice, work hours include attending teacher-led classes, lectures, seminars, doing written assignments, engaging in independent study, etc. Some courses may involve a great deal of teaching, while others are organised such that students work independently.

The programme involves a great deal of independent work, even in the first semester. The first year is devoted to exploring various issues related to art in public spaces, communication theory, production, presentation, facilitating the public's encounter with art, research-based methods and practical assignments related to these issues.

The second year is devoted largely to developing the Master project and to writing a report about its process of creation.

# 1.5.2. Exchange

The study programme accommodates student exchanges in the first semester of the second year. Students may also participate in 'express mobility' exchanges, for instance, a weeklong workshop or similar short courses/projects.

The Department of Art and Craft is a member of several networks of colleges offering specialised education in art and design. Three such networks are Cirrus, KUNO and Erasmus. Many schools in these networks offer relevant courses in public art.

In its teaching, the study programme will make use of international contacts and networks.

# 1.6. Teaching and learning methods

The learning methods are linked to progression in the study programme, which starts with theoretical insight and the application of practical knowledge. The aim of the first year is to provide students with a thorough introduction to issues associated with the study area, so that the knowledge can be applied downline. The second year consists largely of practical work experience, with students working independently on their own Master project. The goal is to use the theoretical and practical knowledge gained in the first year.

Teaching will take the form of courses, practical and theoretical workshops, lectures, seminars, and tutorials – both individually and in groups – as well as independent work.

Teaching will be conducted in Norwegian and English.

# 1.7. Course Requirements

This study programme consists of different courses. Each course must be passed before a student can progress in the programme. Please see the individual course descriptions for further information on course requirements.

Several excursions – some mandatory, others optional – will be organised throughout the study programme. These include some longer international trips and several shorter excursions locally and within Norway.

The study programme is based on mandatory participation: each course and the programme as a whole require an attendance record of minimum 80 %.

## 1.8. Assessment

All course work is assessed by the awarding of either a pass or fail grade.

To progress from one semester to the next, the student must pass all the courses in the previous semester.

The main part of the second year is dedicated to the independent Master project. A board of examiners comprised of one internal and two external examiners will assess this work. The board of examiners will also assess the level of the study programme in relation to the field of public art as a whole.

Please see the individual course descriptions for further information on assessment procedures.

Additional provisions for assessment and examination are set out in the Academic Regulations for Oslo National Academy of the Arts.

# 1.9. Quality assurance

Oslo National Academy of the Arts has implemented systems for ensuring and developing the quality of all aspects of its educational programmes. Students contribute importantly to this work, among other ways, by participating in student evaluations and in the annual Learning Environment Survey.

## **Brief course description**

In Master project, part 1, the student will plan and present a portion of the independent Master project which concerns issues related to public space. By acquiring knowledge about a place, context or situation and its aesthetic, artistic, cultural, political and social peculiarities, the student will work on an independent project in public space. During the process, the student will dialogue closely with the main tutor.

The artistic work can take different forms, from being a traditional sculpture in one or several media, to being an art- or architectural installation, a set of relational actions or a social intervention. A significant portion of the Master project will be to reflect on and discuss political, legal, geographical, economic and/or other preconditions and premises for the artistic work.

The course culminates in a critical review of the development and current status of the student's Master project; the student presents a revised sketch, analysis and plan for how to carry out the Master project as a whole, based on the work done during the course. The student receives feedback which can be applied to Master project, part 2.

Independent artistic practice is a core aspect of the Master programme. It involves in-depth study, independent work and the development of an art project in consultation with the main tutor.

The course also involves considerable independent work, group discussions and receiving feedback from the main tutor and invited guest teachers.

Master project, part 1 includes an artistic component and a written component. The course culminates in a critical review of the project's development and current status: the student presents a revised sketch and plan for carrying out the art project based on the work done during the semester/the course.

#### **Course requirements**

Students are required to participate actively in obligatory group sessions, tutorials and writing workshops. They must also participate in a minimum of three tutorials per semester with the main tutor. In a plenary presentation at the end of the course/semester, they must give an overview of the art project, its development and current status.

#### **Assessment**

Course requirements must be met, and course work will be assessed on the basis of the student's presentation in a plenary session. The latter will be graded on a pass/fail basis.

## Brief description of the course

Contextualisation 1 includes theory, reflection, methodology, art history and, more particularly, the history of public art. The theoretical content ranges from general art theory to specialised theory for art in public spaces. The student will be introduced to, and develop, the ability for critical reflection and discussion in relation to his or her own artistic practice, but also in relation to other fields and areas of activity in society. This should result in the student gaining insight into his or her own artistic standpoint, both as regards theory and methodology. By focusing on socio-historical changes in the understanding of art and public space, the course aims specifically to have the student internalise theoretical insights with a view towards practical use. Through providing the student with analytical tools and practical artistic methods, the course will provide conditions for creating art in public space. It will give historical, art-theoretical and practical artistic insight into the relationships between art and its contexts.

## Brief description of the course

The course focuses on issues related to producing and completing art projects in public space. A core theme is the relation between pragmatic and conceptual challenges and how these influence each other during the development of an artistic project. Technical, organisational, financial, zoning-related and legal aspects of producing art in public spaces are also addressed in order to equip the student to produce art projects in contexts where they can be experienced by the general public.

## Brief description of the course

In Master project, part 4, the student will continue to develop the independent Master project which relates to relevant issues within the field of art and public space. The student will work with this artistic project in public space through acquiring knowledge about a place, a context or a situation and its aesthetic, artistic, cultural, political and social particulars. While working on the project, the student will dialogue closely with the main tutor.

The artistic work can take different forms, from being a traditional sculpture in one or several media, to being an art- or architectural installation, a set of relational actions or a social intervention. The Master project can

involve several artistic strategies and methods that are developed individually or within the context of a group. The project should take into account practical, theoretical, ethical and legal conditions related to the challenges of working with art in public space. As part of the project, the student will reflect on and discuss political, legal, geographical, economic and/or other preconditions and premises for the public work of art.

The course culminates in a review of the project's development and current status. The student presents an analysis of the art project, based on the work he or she has done during the course.

The final project will be evaluated in relation to the choices the student has made in constructing the work and the reasons for making those choices, how the entire project has been carried out and how it is reported. The following aspects will be evaluated:

- a) the artistic research and analysis of the project's location (site), and the specific context's significance for the project.
- b) conceptualisation of the project
- c) the visual representation of the project(s) at the specific site
- d) the analytical, reflective text about the work of art

The Master project must be submitted in the final semester, before the stipulated deadline.

Completion of the art project and its public presentation. Submission of written component. Presentation of the independent project before the board of examiners (the exam).

The independent work, the artistic component and the written component will be jointly assessed by a board of examiners consisting of one internal and two external examiners.

The course will be graded on a pass/fail basis.
