1.1. Brief Outline of the Master's Programme

1.2. Brief Description of the Study

The Master's Programme in Dance is a two-year full-time study that builds on a performing Bachelor's degree in dance or an equivalent education. The programme is a postgraduate specialist study intended for students who want to work as independent dance artists at an international level. The programme aims to develop and stimulate the students' artistic identity as performing and creative dance artists by developing their performative articulation and reflection in both individual and collaborative projects.

The programme provides perspectives that illuminate the art of dance as a cultural expression in aesthetical, historical, political, ethical and social contexts and looks at how theories of art may interact with the practical production of art, and vice versa.

The Master's programme will qualify students to work nationally and internationally either as an independent dancer or in established dance companies, as well as in other contexts within the arts and society.

The programme corresponds to 120 ECTS credits and qualifies students for admission to the PhD in Artistic Research and other relevant doctoral programmes.

1.3. Admission Requirements

The Master's degree programme is based on a three-year Bachelor's degree (180 ECTS credits) in dance or other relevant education. Applicants must document a minimum of 80 ECTS credits within dance and the performing arts. Applicants with a lower content of dance-related or performative subjects in their degree may also apply for admission if they can document through practice/work experience that they have attained a corresponding scope and level in regard to the programme.

In exceptional cases, other documented qualifications may be approved as wholly or partially equivalent to the educational requirements specified above.

Applicants must document their proficiency in English, for example through a TOEFL test with a minimum score of 500, an IELTS test with a minimum score of 5.0 or other equivalent documentation. Applicants who document an educational background from another Nordic country or from an English-language country do not need to submit further documentation of their proficiency in English.

Applicants must submit 1) a letter of motivation and 2) Vimeo uploads (or equivalent documentation) where they act as a performer. On the basis of their application, applicants will be informed whether they will be called in for an admission test and interview.

The admission process will be based on an overall assessment of the applicant in regard to

- their description of and reflection on practising as an independent dance artist
- expressiveness, individuality and creativity within dance
- technical skills within dance
- motivation
- personal suitability

1.5. Structure and Progression

All the courses in the curriculum support, develop and lay a foundation for the professional competence the students will need later during their professional careers, as described above in section 1.4 ("The Programme's Learning Outcomes").

The programme's academic content has been divided into the following courses:

Year 1:

- Movement Practice 1
- Performing and Creative Method 1
- Project and Performance Practice 1
- Performance Theory and Philosophical Aesthetics 1
- Independent Project Proposal

Year 2:

- Movement Practice 2
- Performing and Creative Method 2
- Project and Performance Practice 2
- Performance Theory and Philosophical Aesthetics 2
- Independent Project

ECTS credits are used to indicate the scope of the study/work required by the programme's courses. 60 ECTS credits correspond to a year of full-time study. One ECTS credit corresponds to 25 to 30 actual hours of work by the student. Actual hours of work include teacher-led instruction, lectures, thesis writing, seminars, independent studies, etc.

Some courses may rely heavily on teacher-led instruction, while other courses are geared more towards the students working on their own.

1.6. Teaching and Learning Methods

The education is based on art-, research- and experience-based knowledge and is part of the artistic development at the Oslo National Academy of the Arts. This development is critically reflective and based on the disciplines' autonomy within a changing society.

The programme consists of teacher-led instruction, supervision and independent work. Collaboration is central to certain parts of the programme. The working methods may consist of physical training and creative/exploratory work on dance, practical assignments, group criticism, written assignments, lectures, seminars, demonstrations, independent study, project work, work placement, performances, excursions, exhibitions, talks and concerts.

The teaching takes place in groups and individually, and the focus is on the individual student's development. Taking responsibility for and reflecting on one's own learning are central to the programme. At the same time, the programme also greatly emphasises the individual student's responsibility for the group's progression and for seeing the performing arts as a collective art form. Experience in various forms of collaboration is therefore an essential part of the programme. Projects, showings and performances are central to the programme.

The programme includes an independent artistic work (the Independent Project). This independent artistic work shall demonstrate reflection, understanding and maturation. The students themselves choose which area within the art of performative dance they want to specialise in. In connection with this work, the student will draft a project description and a bibliography of their own choice.

The programme's coursework requirements are

- mandatory attendance
- active participation in the education and at seminars
- completion of all the mandatory assignments in each course

Further information on coursework requirements is available in the individual course descriptions.

The programme is adapted to students who only master English, so that all the courses can be completed and all the academic choices can be made without the student mastering Norwegian.

Provisions on absence and leave have been laid down in [the regulations concerning studies at the Oslo National Academy of the Arts](#).

1.7. Assessment

All coursework requirements must be fulfilled in order for the students to receive their final assessment in the given course.

The students' work in the programme shall be supervised and assessed on an ongoing basis. Supervision and assessment are a continual process related to the programme's learning outcomes and content. The ongoing assessment is based on teacher assessments, reflection on one's own development and fulfilment of the coursework requirements in each course.

In addition to the ongoing assessments, a course may also be concluded with a written reflection, assessment of artistic results in a performance/exhibition or a practical demonstration related to the course's learning outcomes.

The assessment usually takes place in cooperation between the student, teacher/supervisor and/or the programme coordinator. The Independent Project will be assessed by three examiners (two internal and one external).

See the course descriptions for further information on how each course is assessed.

The student must pass all of the first-year courses in order to progress to the second year. All of the programme's courses must be passed in order for the student to achieve the degree of Master of Dance.

The programme uses a pass/fail grading system.

1.8. Quality Assurance

The Oslo National Academy of the Arts has systems for assuring and enhancing the quality of all parts of the education. Students are important contributors to this work, for example by participating in student evaluations and the annual learning environment survey.

Brief Description of the Course

The course develops and challenges the student's movement skills and kinaesthetic understanding. The course will emphasise various techniques and methods within dance, and the course may in addition contain alternative movement practices.

Students are given the opportunity to challenge and expand their physical potential, with the student's ability to articulate and explore movement and dance being central to the course.

In consultation with the programme coordinator, students shall establish a movement practice that is relevant to their own specialisation.

basis of course assignments. The course is graded pass/fail.

Brief Description of the Course

The course illuminates the dancer's practice, knowledge and awareness of stage presence and expression. Through encounters and workshops with dance artists and other creative and performing artists, students will gain insight into methods and various strategies for physical articulation and performative expressions. Experience-based learning, by solving various artistic and performer-specific assignments, gives the students self-confidence to develop their own performing and creative methods and thereby prepares them even more to work on performances and productions.

This course also includes an introduction to stagecraft elements and other various artistic tools. Collaborations with other students, primarily at the Academy of Dance but also other programmes, are an integral part of the course.

Brief Description of the Course

The course shall provide experience with and competence in practising, creating and presenting dance in relation to various spaces and stagecrafts elements, contexts and audience strategies. Students will gain insight into various approaches to artistic research and development through encounters with choreographers, educators, composers and other creative artists, and shall through process-related work develop their abilities to structure relevant movement material and be able to give artistic form to this material.

The course may include the development of new artistic works and the rehearsal of an existing repertoire. Collaborations with other students at the Academy are an integral part of the course.

The course also provides insight into the dancer's professional role and questions of professional ethics as well as an understanding of finances, infrastructure and various actors in the national and international field of dance.

The course emphasises the dancer as the initiator of his or her own activity and/or collaborations through knowledge of for example project planning, application writing and network building.

The course's working methods may include teacher-led instruction, supervision and independent work. It may include practical exercises and showings, creative assignments, lectures, independent study, project work and written assignments.

The course's teaching, progression and aims are adapted to the student group's composition.

The course requirements are

- mandatory attendance and active participation in the course
- completion of course assignments throughout the course

Assessment

All course requirements must be approved in order for a student to receive a final course assessment.

The student's coursework will be assessed on an ongoing basis. The ongoing assessment is based on supervision, teacher assessments and the student's own reflection on his or her professional development in relation to the learning outcomes.

In addition to the ongoing assessments, the student's artistic results will be assessed separately during performances. This assessment will be made by the given educator/choreographer and the programme coordinator.

The course is graded pass/fail.

2.1.4. Performance Theory and Philosophical Aesthetics 1

Brief Description of the Course

The course illuminates select topics and problems within performing practices, dance theory and contemporary philosophical thinking. The focus is on a critical investigation of the concepts and analyses that the art of dance draws from within the Western heritage of the humanities, aesthetics, cultural studies and social sciences. The course also addresses critical race theory, intersectionality, postcolonial studies, queer theory and other relevant perspectives that reflect the students' specific interests.

Semester 1 (year 1) provides an introduction to:

- key topics and problems within dance and the performing arts
- analysis of works within modern dance and contemporary dance

Semester 2 (year 1):

- introduction to historical and contemporary concepts within aesthetics and art criticism

The course provides an introduction to and experience with various approaches to writing that may include academic essays, project descriptions, reflections and the like.

Teaching and Learning Methods

The course's working methods will consist of teacher-led instruction, supervision and independent work/independent study. Teacher-led instruction will primarily take place as lectures, seminars and textual analysis. The teacher determines the syllabus for each of the two academic years in accordance with an assessment of the cohort's priorities and their academic progression.

The teaching negotiates with the group's composition and other salient factors. Dialogue and discussion of key questions related to central topics and professions will be central.

In addition to teacher-led instruction, students are expected to read a selection of articles and books as preparation for lectures and as part of their written assignments. The students will be actively engaged in current theoretical research, and they will expand their knowledge of and familiarity with specialised literature and also go in depth into specific fields. The students submit two essays on topics or literature assigned by the teacher.

The course requirements are

- mandatory attendance and active participation in the course
- completed reading
- submission of written assignments/works

Assessment

All course requirements must be approved in order for a student to receive a final course assessment. Written assignments/works will be assessed by the teacher and be seen in relation to the course's learning outcomes.

The course is graded pass/fail.

2.1.5. Independent Project Proposal

Brief Description of the Course

In the first part of the Independent Project Proposal course, students shall explore their own concepts, methods and ideas. The project may be an independent investigation or be part of a larger artistic project. The work may include collaboration with a choreographer, fellow students or other artistic partners. In the second part of the course, and on the basis of this initial period of exploration, students shall write a project description for their second-year Independent Project. The project description shall contain a relevant methodological and artistic problem for the self-chosen work.

All course requirements must be approved in order for a student to receive a final course assessment. The project description shall be approved by the programme coordinator and the dean.

The course is graded pass/fail.

An approved project description is required for students to begin working on their Independent Project.

The course's teaching, progression and aims are adapted to the group's composition.

The course requirements are

- mandatory attendance and active participation in the course
- completion of course assignments throughout the course

Assessment

All course requirements must be approved in order for a student to receive a final course assessment.

The student's coursework will be assessed on an ongoing basis. The ongoing assessment is based on supervision, teacher assessments and the student's own reflection on his or her professional development in relation to the learning outcomes.

In addition to the ongoing assessments the student's artistic results will be assessed separately during performances. This assessment will be made by the given educator/choreographer and the programme coordinator.

The course is graded pass/fail.

Brief Description of the Course

The course illuminates select topics and problems within performing practices and contemporary philosophical thinking. The focus is on a critical investigation of the concepts and analyses that art draws on within the Western heritage of humanism, aesthetics, cultural studies and social sciences. The course also addresses critical race theory, intersectionality, postcolonial studies, queer theory and other relevant perspectives that reflect the students' specific interests.

In semester 3 (year 2), the course focuses on

- contemporary discussions within the arts and culture

The course provides an introduction to and experience with various approaches to writing that may include academic essays, project descriptions, reflections and the like.

The Course's Learning Outcomes

Teaching and Learning Methods

The course's working methods will consist of teacher-led instruction, supervision and independent work/independent study. Teacher-led instruction will primarily take place as lectures, seminars and textual analysis. The teacher determines the syllabus for each of the two academic years in accordance with an assessment of the cohort's priorities and their academic progression.

The teaching negotiates with the group's composition and other salient factors. Dialogue and discussion of key problems related to important topics and professions will be central.

In addition to teacher-led instruction, students are expected to read a selection of articles and books as preparation for lectures and as part of written assignments. The students will be actively engaged in current theoretical research, and they will expand and develop their knowledge of and familiarity with specialised literature. The students submit an essay on a self-chosen topic and literature approved by the teacher.

The course requirements are

- mandatory attendance and active participation in the course
- completed reading
- submission of written assignments/works

Assessment

All course requirements must be approved in order for a student to receive a final course assessment. Written assignments/works will be assessed by the teacher and be seen in relation to the course's learning outcomes.

The course is graded pass/fail.

Brief Description of the Course

The Independent Project course (i.e. the Master's project) is a specialization that focuses on the development of a work of performative dance. By applying and integrating insight from the programme's other courses, the students shall plan, explore, develop and realise an artistic problem of their own choosing. The course greatly emphasises the students' artistic individuality and independence, and students are expected to be able to demonstrate maturity and reflection in their solutions and choices. The project may be an independent investigation or part of a larger artistic project. The work may include collaboration with a choreographer, fellow students or other artistic partners. The work will normally be done internally at the Academy but may in exceptional cases be done in cooperation with an institution/actor in the professional field. The Independent Project shall be carried out in line with ethical requirements and guidelines, and a particular emphasis is placed on the positive collaboration with others involved, artistically and technically.

The artistic work is the main part of the Independent Project, but in addition the student shall document, submit and present a reflection on both the process and the outcome. Students will be able to relate knowledge and skills from the Performance Theory and Philosophical Aesthetics course to their own artistic work.

The Course's Learning Outcomes

Teaching and Learning Methods

The coursework will consist of independent work and supervision. It may also include teacher-led instruction. The course's working methods will primarily be independent artistic work, project work, written work and independent study.

For their Independent Project, each student shall have a supervisor affiliated with the Oslo National Academy of the Arts. Students are responsible for their own progression in the Independent Project, and must themselves see to that they regularly meet with and submit material to their supervisor so that the planned progression is maintained. Any changes to the project description must be approved by the programme coordinator.

The course requirements are

- submission of an independent artistic work
- submission of a written reflection
- mandatory attendance and active participation in the course

Assessment

All coursework requirements must be fulfilled in order for the student to receive the final course assessment.

The student's coursework will be assessed on an ongoing basis. The ongoing assessment is based on supervision, teacher assessments, group discussions and independent reflection on one's academic development as seen in relation to the course's learning outcomes.

In addition to the ongoing assessments in the course, there will be an assessment of the artistic part and the written reflection of the Independent Project. The assessment is made on the basis of the course's learning outcomes and how these are expressed in the Independent Project.

The Independent Project will be assessed by a panel consisting of an external examiner and two internal examiners. Both the artistic work and the written reflection must be passed in order for the student to pass the course.

The course is graded pass/fail.
