**Information and Consent - Transfer of personal data**

This is a template for informed consent when transferring personal data from Oslo National Academy of the Arts to an individual artist.

**Do you consent to the transfer of personal data in the artistic expression**

**Purpose of the transfer**

You have previously agreed to participate in an artistic research project led by

Insert name of The Artist

Oslo National Academy of the Arts (hereafter KHiO) is the data controller of your personal data under this original agreement.

The Artist who has created the artistic expression that includes personal data (hereafter Artistic Personal Data) wishes that the personal data can be transferred to The Artist.

The purpose of the transfer is the further processing of the Artistic Personal Data as artistic expression by The Artist. This includes sharing, displaying and creating new artistic expressions.

**Who is responsible for the personal data under this consent?**

is an independent controller of the personal data transferred under this agreement, and responsible for the personal data.

**Why are you being asked to consent to the transfer?**

You have originally given consent to the processing of your personal data on the condition that KHiO's management system for information security and privacy that applies. The information under this original consent is secured in many ways, technical and organisational. This prohibits the transfer of personal data to another individual.

The Artist must obtain your separate consent to this transfer, if the transfer is to take place.

**What does consent involve for you?**

If you consent to the transfer to The Artist, you agree that The Artist can use your personal under new conditions.

**Participation is voluntary**

Participation to the transfer is voluntary.

It will not be possible for you to withdraw from this separate new consent. The personal data controlled by The Artist will not be protected in any way, and the expression can also be transferred to countries where the GDPR does not apply.

**Your personal privacy**

The Artist wishes to use the personal data for the purpose of artistic expression. This means that the Personal Data Act §3 "Relation to freedom of expression and information" comes into effect. It provides exemptions from parts of the GDPR. "As far as it is necessary for the exercise of the right to freedom of expression and information, the GDPR and this law do not apply here processing of personal data for journalistic purposes or with a view to academic, artistic or literary expressions."

If you consent to the transfer, the personal data is left at The Artist's unlimited disposal by means of a general contractual consent (not a GDPR consent). The Artist can use the personal data for display in exhibitions, publishing on the web or creating new artistic expressions.

Irrespective of what follows from the first paragraph of §3, no exceptions can be made to the personal data protection regulation articles 24, 26 etc., according to paragraph §2. But since an artistic expression is basically intended for display, this will be meaningless. The entire GDPR will therefore not be valid after this transfer.

**What will happen to your personal data at the end of the research project?**

There are no requirements for The Artist to delete your personal data at the end of the artistic work.

**Your rights**

Since the entire GDPR will not be valid, you have no rights under the Personal Data Act.

**What gives The Artist the right to process your personal data?**

The Artist can only process your personal data if you give your consent.
